## Terms and Conditions:

### 1. Bookings

We will confirm your place in the Workshop once your payment has been confirmed.

### 2. Payment

Payment of all registration fees (Registration Fees) must be received prior to attendance. A 50% deposit by bank transfer is required once you have been accepted to the Grande Maison masterclass programm, and the remaining 50% one week before the start of the masterclass. Early Bird Pass Tickets are limited tickets first come first serve. Early Bird Pass Tickets are always due for payment immediately. Only the time passes (very limited tickets, first come first served) could be purchased using the payment plan. Payment Plan Pass (access on all days) payable in 3 Installments plus (amount plus 5% service fee) per month on the 01st or 15th on a month.

### 3. Workshops

(a) To secure a place in a Workshop you must pay the Registration Fee in advance on a "first in first served" basis.

(b) All Workshop numbers are capped and we reserve the right to modify the cap number as is deemed necessary.

## 4. Participation
